EV Chargers at Hyannis Transportation Center








Did you know you can charge your Electric Vehicle at HTC?

If your fleet relies on electricity to re-fuel, this is a very serious piece of the puzzle to consider. With winter storms and hurricane winds, CCRTA wants to prepare for any power outages that may arise as we transition to an Electric Fleet. That's why our ZEV Study includes a report to identify different options for energy resiliency.

Smart Grid Grant: Microgrid

In partnership with the Cape Cod Gateway Airport, CCRTA has been awarded approximately \$2 million to plan a microgrid!

A microgrid is a local energy production and distribution network that can function independently when disconnected from the main electrical grid. A microgrid will be an important piece to CCRTA's journey to a zero-emission future because it will have the ability to generate and store green energy. This award is a perfect compliment to the Energy Resiliency Report.

This past fall, in partnership with the Airport, we jointly applied for phase 1 (of 2) of a new grant program for the study and planning of a microgrid placed at the Cape Cod Gateway Airport. We have been awarded phase 1, which is meant to plan out the microgrid. There will be a future phase where we will apply for the funding to build it.

The other deliverable from Hatch since our last newsletter was the **Asset Inventory Template**.

In requesting this template as part of the ZEV Study, our plan is to use it to document what we have for transportation-related assets, infrastructure, and related operations now and to track how that changes over the course of our transition.

This template will be the foundation for a later deliverable of performance metrics to measure GHG emission reductions as the journey continues.
